Resolution No. 1 Series of 2011-2012

A RESOLUTION IMPLEMENTING THE LAND TRANSPORTATION FRANCHISING AND REGULATORY BOARD MEMORANDUM CIRCULAR NUMBER 2005-014

WHEREAS, the 2010 Constitution of the Central Student Government (CSG) of Holy Name University stresses on the protection of the rights and welfare of the students;

WHEREAS, the students of Holy Name University take a ride from the Lesage Campus to the Janssen Heights Campus and vice versa, to attend classes, meetings and/or other transactions in both campuses;

WHEREAS, the students of Holy Name University pay an amount of Php8.00 as minimum fare for public transportation vehicles;

WHEREAS, there is an existing Land Transportation Franchising and Regulatory Board Memorandum Circular Number 2005-014, Supplement To Memorandum Circular No. 2003-033 (Re: Grant Of Fare Discounts To Elderly, Disabled Persons And Students), declaring that every student is entitled to 20 percent (20%) discount on fare from Mondays to Fridays provided however, that the fare discount may be availed of only during the period of their enrollment;

WHEREAS, the CSG sympathizes the financial constraints experienced by the PUV Drivers and operators of DAFILODA; hence the amount of Php7.00 will be collected from the students instead of Php6.40 (supposed discounted fare).

NOW THEREFORE, be it resolved that:

- 1) The minimum fare to be collected from students of Holy Name University shall be Php7.00 in Public Utility Vehicles with routes from the HNU Lesage Campus to the HNU Janssen Heights Campus and vice-versa;
- 2) Furnished copies of this resolution shall be distributed to the PUV Drivers and Operators of DAFILODA and be posted in their respective public vehicles after its complete publication; and

3) Leaflets shall be distributed to the students informing them about the implementation of this resolution.

WHEREFORE, be it resolved finally that the minimum fare to be collected from students of Holy Name University shall only be Php7.00 in Public Utility Vehicles with routes coursing the both campuses, with copies of this resolution furnished, distributed to the students via leaflets and posted in conspicuous areas of the University after seven (7) days of its complete publication.
